NEBA ACTIVITIES WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

The mission of New England Book Artists Corporation (NEBA) is to educate, serve, enrich, and to encourage appreciation and understanding of visual/text art through direct engagement with book arts and book arts related works and materials. As part of its mission, NEBA provides its members and the broader community with opportunities to view, reflect upon, research, teach, learn from, and interpret the creative works and processes of its members and other artists through physical, online, performance-based and other exhibitions and related activities.

In consideration for NEBA and/or NEBA members, agents, volunteers, or employees (collectively "NEBA agents") providing information, activities, or services including but not limited to transportation to or from NEBA-related activities, participation in NEBA-sponsored activities, communications, or other benefits and opportunities provided by NEBA and/or its members and agents (collectively "NEBA activities")---

- 1. I, for myself, my personal representatives, heirs and assigns, hereby release, waive, discharge, and covenant not to sue NEBA, the Board, its individual Members, or other NEBA agents from liability from any and all claims, resulting in personal injury, accidents, illnesses (including death) and property loss arising but not limited to participation in NEBA activities.
- 2. I, for myself, my personal representatives, heirs, and assigns, agree to save, hold harmless and indemnify NEBA and NEBA Members and agents against any and all liability, claims, demands, actions, and causes of action whatsoever, including attorneys fees, arising out of or related to any loss, damage, or injury, illness (including death), brought as a result of my involvement in a NEBA activity, including, but not limited to, transportation by a NEBA Member or NEBA agent.
- 3. The undersigned further expressly agrees that this Waiver of Liability and Hold Harmless Agreement is intended to be as broad and inclusive as permitted by the laws of the Commonwealth of Massachusetts and that if any portion thereof is held invalid, the balance shall, notwithstanding, continue in full legal force and effect.
- 4. In signing this release, I acknowledge and represent that I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it, and sign it voluntarily as my own free act and deed.
